#### **REGULAR SESSION**

#### Action:

#### Item 1 Election of NCT9-1-1 Board Officers and Determination of Initial Terms

Christy Williams stated that the first item was the election of NCT9-1-1 Board officers and determination of initial terms. Following the initial term, elected officials will serve staggered, two-year terms but the number of terms a Board member can serve is unlimited.

Officers will be elected at the first meeting of each year. The following slate was presented for 2019: President – Stephen Terrell, Mayor, City of Allen Vice-President – Jerry Stringer, Commissioner, Johnson County Secretary – Roger Deeds, Sheriff, Hood County

The floor was open for additional nominations. None were presented.

#### Attachment A

Upon a motion from Judge Danny Chambers (seconded by Councilmember La'Shadion Shemwell), and by unanimous vote of all members presented, the Board approved the slate as presented.

Secretary Roger Deeds facilitated the lottery of terms. The following seats will serve an initial two-year term: Rockwall County, Erath County, City of Allen, Somervell County, Palo Pinto County, Kaufman County, Johnson County, City of Frisco, Collin County, and Wise County. The following seats will serve an initial one-year term: Parker County, City of McKinney, Navarro County, Cities of Dallas County, Ellis County, Hunt County, City of Prosper, City of Murphy, and Hood County.

#### Item 2 Resolution Adopting NCT9-1-1 Policies

Christy Williams asked for approval of the following policies which are above the staff level and may have involvement from some cities and/or counties.

a. Board of Managers Travel

Based on a request from the Board, Christy Williams will have 9-1-1 staff develop additional guidance on selecting priority for Board travel and will present to the Board at a later date.

Upon a motion from Judge Danny Chambers (seconded by Sheriff Harold Eavenson) and by unanimous vote of all members present, the Board approved the resolution as presented.

#### Item 3 Resolution Approving the NCT9-1-1 Fiscal Year 2019 Strategic Plan

Christy Williams presented the Fiscal Year 2019 Strategic Plan for approval. The Strategic Plan is an annual exercise in which staff determines the goals, objective and corresponding projects for the upcoming fiscal year. The projects in this plan are tied to budget numbers previously approved by the North Central Texas Council of Governments and the Commission on State Emergency Communications (CSEC). The Strategic Plan is the narrative that explains how the budgeted dollars will be spent.

Commissioner Jerry Stringer requested further review of the GIS maintenance model but requested that the Board move forward with approval of the plan. Christy Williams did a high-level explanation of the plan for those unfamiliar. Rodger Mann, 9-1-1 GIS Manager, will make a presentation at the March meeting regarding the maintenance model.

There was a discussion of what is required to add an item to the agenda. LeAnna Russell, 9-1-1 Data Supervisor, will serve as a liaison and a Board member may present requests for items to be added to the agenda. There will be a deadline for submitting requests. Initially, one request will be sufficient but that may be revisited by the Board in the future.

There was discussion regarding Board liability in relation to 9-1-1 outages. Legal counsel for NCT9-1-1 explained that there are both statutory and insurance protections that apply to the Board.

Upon a motion from Sheriff Roger Deeds (and seconded by Councilmember Jeff Hodges) and by unanimous vote of all members present, the Board approved the resolution as presented.

#### Item 4 Resolution Authorizing an Agreement with the Texas 9-1-1 Alliance

Christy Williams asked the Board to authorize an agreement with the Texas 9-1-1 Alliance. She presented an overview of the change from having CSEC as a resource to the District world. The Texas 9-1-1 Alliance provides services for any joint issues in 9-1-1: legal, lobbyists, national standards, etc.

Upon a motion from Councilmember La'Shadion Shemwell (and seconded by Mayor Pro Tem Jennifer Berthiaume) and by unanimous vote of all members present, the Board approved the resolution as presented.

#### Item 5 Resolution Authorizing FY 2019 Agreement with Public Safety Answering Point Entities

Christy Williams asked the Board to authorize agreements with the Public Safety Answering Point Entities within our service area. She presented the history of these interlocal agreements which originally were required by CSEC. Staff recommends continuing these agreements which outline the responsibilities of both parties, the PSAP and NCT9-1-1. In the past, the agreements were sent out biannually. The previous biannual agreement was extended because of the District formation so staff committed to sending out a new agreement once the district was created. The term of the agreement will expire September 30, 2019, and will be executed in two-year increments going forward.

Upon a motion from Sheriff Harold Eavenson (and seconded by Councilmember La'Shadion Shemwell), the Board approved the resolution with a vote of 16 for and one abstention.

#### Item 6 Director of 9-1-1 Report

- Christy Williams presented information about the Strategic Advisory Committee including the
  roles and responsibilities of the committee. 9-1-1 staff are currently slating considerations for
  Board approval. Former members of the Regional Advisory Committee not eligible to serve on
  the 9-1-1 Board of Managers will be included. In addition, there will be representation from
  different factions including: police, fire, emergency services, emergency management, and PSAPs.
  Any recommendations can be sent to LeAnna Russell.
- 2. Correspondence to the 9-1-1 Board of Managers will come primarily from Christy Williams.
  - a. The request was made for Board members to ensure emails from the program are unblocked.
  - b. The request was made to include on the Board profile sheet any additional staff who should be included on correspondence.
  - c. Board members will also be included on newsletters and outage notifications.
- 3. For future meetings, only electronic Board packets will be provided. The Board agreed to bring their own devices or print the packets.
- 4. The previous Regional Advisory Committee Vice-Chair, Judge Bruce Wood, received the 9-1-1 Government Leader award from the 9-1-1 Institute and will travel to Washington, D.C. to accept his award.

constituting a quorum should not gather outside of the Board meetings to discuss NCT9-1-1 business.

- 2. There was a discussion of which areas of the PSAP agreements were of concern to some entities.
- 3. Additional information was requested regarding the December 28, 2018, outage. Christy Williams provided information on the nationwide outage and clarification that it was outside of the 9-1-1 system but affected 9-1-1 service.

A motion to adjourn was made by Sheriff Harold Eavenson (and seconded by Councilmember La'Shadion Shemwell). There being no other business, President Steve Terrell adjourned the meeting at 11:05 AM.

Item Title: Appointments to the NCT9-1-1 Strategic Advisory Committee

The NCT9-1-1 Bylaws provide for a technical advisory committee. Whereas the NCT9-1-1 Board of Managers is the policy-making body for the District, the NCT9-1-1 Strategic Advisory Committee will serve as the audience for programmatic strategy, project vetting, and updates. The committee will serve as the first line of review for the annual strategic plan and will be briefed on current and upcoming projects. The committee will also be used as an outlet to gauge interest, field concerns, and answer questions. Staff envisions subcommittees for individual projects where members of the NCT9-1-1 Strategic Advisory Committee will be asked to serve as subject matter experts.

The committee will be comprised of staff members from the public safety community with varied areas of programmatic expertise. In developing recommended appointments, staff provided members of the previous NCTCOG 9-1-1 Regional Advisory Committee (RAC) who were not eligible to serve on the 9-1-1 Board of Managers first opportunity to serve on the new committee. The positions provided to RAC members will not renew once the RAC member no longer serves.

The NCT9-1-1 Board of Managers is being asked to consider the appointments included in Attachment B to the Strategic Advisory Committee, which serves as the technical advisory committee stipulated in the NCT9-1-1 Bylaws.

Item Title: Resolution Adopting the NCT9-1-1 Policy on Third-Party Access to Telecommunications

Towers

A network of telecommunications towers supporting 9-1-1 operations is currently installed at strategic locations throughout the NCT9-1-1 service area. The purpose of these towers is to increase resiliency and redundancy of the NCT9-1-1 system. The towers were erected pursuant to Interlocal agreements (ILAs) with the local governments on whose real property the towers reside. The towers and ILAs were transferred from the North Central Texas Council of Governments (NCTCOG) to NCT9-1-1 which now has ownership and responsibility for operation and maintenance.

Included in the ILAs is the ability for third-party entities to install additional equipment on the towers if certain requirements are met. In order to ensure consistency and protect these assets, staff recommends a Board policy to govern the consideration of these requests.

The draft NCT9-1-1 Third-Party Access to Telecommunications Towers policy is attached for your consideration (Attachment C).

Future changes to the above policy will require Board approval. In addition, procedures and guidelines will be maintained internally to guide staff on details of program operation.

#### RESOLUTION ADOPTING THE NCT9-1-1 POLICY ON THIRD-PARTY ACCESS TO TELECOMUNICATIONS TOWERS

WHEREAS, the North Central Texas Emergency Communications District (NCT9-1-1) was created pursuant to Chapter 772, Subchapter H, of the Texas Health and Safety Code as amended by the 84th Legislature, through the passage of resolutions by County Commissioners Courts and City Councils within the NCT9-1-1 service area; and,

WHEREAS, the NCT9-1-1 service area consists of Collin, Ellis, Erath, Hood, Hunt, Johnson, Kaufman, Navarro, Palo Pinto, Parker, Rockwall, Somervell, and Wise counties, as well as the Dallas County cities of Balch Springs, Cockrell Hill, Sachse, Seagoville, and Wilmer; and,

**WHEREAS,** NCT9-1-1 is a political subdivision of the State and carries out essential governmental functions related to the provisioning of emergency communications services; and,

**WHEREAS,** NCT9-1-1 is engaged in the planning, implementation, and maintenance of an emergency 9-1-1 system for more than 40 Public Safety Answering Points within its 9-1-1 service area; and,

**WHEREAS,** NCT9-1-1 operates and maintains a network of telecommunications towers installed in strategic locations throughout the NCT9-1-1 service area and has capacity to allow third-party access to such towers; and,

**WHEREAS**, staff recommends the adoption of certain polices to promote effective and efficient operations to carry out NCT9-1-1's mission; and,

WHEREAS, any subsequent changes to the approved policies will require Board approval.

# NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:

**Section 1.** The NCT9-1-1 Board of Managers hereby adopts the NCT9-1-1 Policy on Third-Party Access to Telecommunications Towers contained in Attachment C.

**Section 2.** This resolution shall be in effect immediately upon its adoption.

POLICY STATEMENTS: A network of telecommuncations towers supporting 9-1-1 operations is currently installed at strategic locations throughout the NCT9-1-1 region. The purpose of these towers is to increase resiliency and redundancy of the NCT9-1-1 system. The towers were erected pursuant to Interlocal agreements (ILAs) with the local governments on whose real property the towers reside. The towers and ILAs were transferred from the North Central Texas Council of Governments (NCTCOG) to NCT9-1-1 which now has ownership and responsibility for operation and maintenance.

Included in the ILAs is the ability for third-party entities to install additional equipment on the towers if certain requirements are met. These third-party requests are from the following categories: 1) a local government with a tower site and corresponding ILA and 2) a private third-party.

The following criteria must be met for a local government's request to install additional equipment to be considered:

- The additional equipment must meet tower load requirements.
- The additional equipment must owned by, and solely to the benefit, of the local government.
- The additional equipment must not interfere with 9-1-1 operations.
- The additional equipment must not be revenue producing.

The following criteria must be met for a private third party's request to be considered:

- The additional equipment must meet tower load maximums.
- The additional equipment must not interfere with 9-1-1 operations.

If requests meet the aforementioned criteria, NCT9-1-1 will considered it for approval. NCT9-1-1 has the right to decline a request based on other factors, including requests in opposition to NCT9-1-1's mission and values.

If approved, local government equipment may be added and maintained at its sole expense and with no direct charges from NCT9-1-1. All expenses related to the installation of the local government's equipment, as well as NCT9-1-1 analysis and potential tower improvements as a result of the equipment installation, are the responsibility of the local government.

If approved, private third-party equipment may be added and maintained at the private third-party's sole expense and fees will be assessed by NCT9-1-1. NCT9-1-1 will utilize market rates and other factors to determine appropriate lease rates for each site. All expenses related to the installation, operation and removal of the vendor's equipment, as well as NCT9-1-1 analysis and potential tower improvements as a result of the equipment installation, are the responsibility of the vendor.

Requests will be considered on a first come, first serve basis. In the event tower space or loads are met or exceeded, no further requests will be considered for that location.

Updates to and/or replacement of installed third-party equipment will require a new request.

Any revenue received by NCT9-1-1 will be used for cost recovery and maintenance of the towers.

NCT9-1-1 staff will conduct regularsite surveys to ensure ongoing compliance and maintain an inventory of third-party equipment installed at all telecommunications tower sites.

**ACTIONS REQUIRED:** The NCT9-1-1 Board of Managers directs staff to develop and implement procedures and processes to implement this policy, to include the criteria defined herein as well as the following additional elements:

Before installing any third-party equipment, the local government or private third-party must:

- I. Send a written request to NCT9-1-1 at least thirty (30) days in advance of requested installation date. A "Tower Information Sheet" specific to the requested location will be provided to requestor and must be filled out and returned to NCT9-1-1 to be evaluated for approval.
- II. NCT9-1-1 utilizes its telecommuncations tower vendor to evaluate the information for compliance with loading requirements, and confirmation that the request would not interfere with 9-1-1 operations.
- III. NCT9-1-1 makes final determination based on applicable factors.
- IV. NCT9-1-1 will notify requestor of approval/rejection of request in writing.

In the event of conflict or ambiguity with any submitted request, the NCT9-1-1 Executive Director shall have final authority and discretion to approve or deny such request.

# North Central Texas Emergency Communications District January/February 2019 Accomplishments

- 1. Christy Williams met with FCC Commissioner Rosenworsel and staff completed a successful business review session with Comtech management to discuss mitigation of service disruptions.
- 2. LifeCare secondary PSAP equipment was installed and is ready for cutover to live traffic in early March.
- 3. Seventeen of the 35 sites have new Uninterrupted Power Supplies installed.
- 4. The Springtown microwave tower has been erected and equipment installed. Rockwall County/Royse City tower is complete and equipment installed. Both sites are passing live 9-1-1 traffic.
- 5. The Regional Telecommunicator Academy #007 concluded with 17 graduates.
- 6. The City of McKinney's Council approved the installation of the low-water sensor system. The GIS Team configured and tested the design of a similar system belonging to the City of Grand Prairie to prepare for McKinney's system. Rodger Mann was interviewed by the Emergency Management Magazine.
- 7. The integration of the Waze feed into the PSAPs was tested in the lab environment and is working. Once deployed in the PSAPs, this functionality will allows for information provided by Waze users to be visible to the Telecommunicators. Waze data is often more timely and provides another data set to help Telecommunicators do their jobs.
- 8. The Texas 9-1-1 Alliance agreement was executed.
- 9. Due to RapidSOS integration in the GIS Dispatch Mapping product, deputies in Wise County were able to locate an emergency caller which resulted in discovering abused children at the caller's residence. The story was picked up by both local and national news including a story on Inside Edition.


